PAYMENTS

Full Time care (6 hours or more) shall be **\$40** per day

Part Time care (under 6 hours) shall be **\$25** per day

Payment can be paid at the beginning of the week, the end of the week, or bi-weekly.

Acceptable forms of payment include: cash, personal check, Venmo and Zelle.

CHILD ABSENCE

If a parent plans a vacation or the child will not be in care, the provider must be given a **2 week notice**. Parents are *not* expected to pay during their schedule absence if a **2 week notice** is given. If the child does not arrive for a scheduled day and no notice has been given to the provider, parents are still expected to pay.

CHILD ILLNESS

When child is ill, the parents are expected to make every effort to give the provider as much notice as possible. Parents are expected to pay on child sick days. AZ Kid Clubs allows 1 Free sick day per month. There is a **24 hour fever/vomit free policy**. The child must be fever/vomit free for 24 hours before returning to AZ Kid Clubs.

LATE FEE

Closing time for AZ Kid Clubs is 5:30 pm. There will be a **\$1 per minute** late fee for every minute after 5:30 pm.

TRIAL WEEK

The first week is considered "trial week". This is a time where the provider and the parents decide if AZ Kid Clubs is a good fit for all. This will be discussed on the last day of care on trial week.

FOOD

Any child under the age of 1 year must have food and formula provider by the parents. AZ Kid Clubs will provide the food for all other ages. If your child like particular foods/ snacks or has an allergy, parents must provide food. AZ Kid Clubs follows a menu and will only make what is scheduled for that particular day.

DIAPERS AND WIPES

Diapers and Wipes will be provided by the parents. _____ (initial)

TERMINATION OF CONTRACT / DAYCARE SERVICES

This contract may be terminated by the parent(s) or the provider. A **2 week notice** prior to the last date of care is required by the parent. The provider may immediately terminate this contract without any notice for any reason. If the parents do not provide a 2 week notice before the end of care, they will be required to pay for the 2 weeks of care. Payment is due whether they receive care from AZ Kid Clubs or not.
